4. Graafschap Fire Department.

Fire Chief Doug DenBleyker was absent with notice, but submitted the following report;

The Planning Commission has referred this to the Fillmore Township Board of Trustees and has also requested a Land Landscape Plan.
- c. The Planning Commission looked at Land Use changes in several different areas of the Township. Discussion of these changes to continue at the May 11, 2020 meeting.
